ORDER OF SUSPENSION

The Court having determined, pursuant to sections 265.00(10) and 400.00 of the Penal Law of the State of New York, based upon an investigation currently underway against Bridgette A. Tojek, that there is a substantial, present issue as to whether Bridgette A. Tojek meets the fitness, character, and eligibility requirements for the privilege of a pistol license within the State of New York; and the Court having scheduled a hearing for purposes of investigating into whether said Bridgette A. Tojek meets the criteria for a pistol license, pursuant to New York State Penal Law section 400.00; and the Court having duly considered the interest of public safety, and having determined that an order of suspension of such pistol license is appropriate and warranted under the circumstances; and upon due deliberation, it is hereby

ORDERED that the pistol license of Bridgette A. Tojek is hereby suspended until further order of this Court; and it is further

ORDERED, that the Sheriff of Allegany County shall forthwith seize the pistol license and all handguns in the possession and control of Bridgette A. Tojek.
